- 3. No advance payment will be made. The approved contractor shall submit their bill (in triplicate) on completion of awarded job and payment will be made within three or four week after compilation of work/submission of bill.
- 4. The order can be terminated by this office at any time without assigning any reason, if the supplied items are not found as per make. In this connection, the decision of Director/NMNH shall be final and binding on the contractor.
- 5. The contractor or his authorized representative could be present at the times of opening of quotation, if they so desire.
- 6. It should be ensured by the firm that the work should be done as per specification; in case any discrepancy will later on found then penalty will impose on the firm as decide by the Director/NMNH under his discretion power.
