The quotations may be sent to Director, NMNH (6<sup>th</sup> Floor), FICCI Museum Building, Tansen Marg, New Delhi-110001 in sealed cover superscribed " QUOTATIONS FOR PRINTING/SUPPLY OF TABLE CALENDARS " latest by 3.00 PM on 15th November, 2013. Quotations received after stipulated date/time shall not be entertained. The quotation may be sent along with a pay order/Banker's Cheque of Rs.5,000/- (Rupees five thousand only) drawn in favour of Pay & Accounts Officer, M/o Environment & Forests, New Delhi towards Earnest Money Deposit which will be refunded after completion of supply.

3. The supply will be governed by the following terms and conditions:

(a)The rates quoted in response to the quotations will remain in force from the date of finalization of rates without any change whatsoever.

(b)The articles should be in original/standard quality.

©The rates should be inclusive of delivery charges to NMNH Office.

(d) The bidder should be a reputed supplier of printing items with a experience of 2-5 years for supply of said items in Govt. Offices and also having sound financial standing with annual turnover of Rs.50.00 lakh. Bidder should indicate their yearly turnover, PAN No., Service Tax/Vat Registration No.

(e)Any calendar which is found to be defective, or not of the desired quality, etc. shall be returned by this office and the order placed therefore, shall stand cancelled.

(f) The items should be supplied within 20 days from the date on which final proof of printing of Calendar is passed by this office. The office will have the authority to cancel any order, if the required items are not printed/supplied on time.

(g)Govt. Taxes/Vat as applicable from time to time on such items, shall be payable by this office. The bill raised by the firm should have all tax registration numbers printed on the bill.

(h)It will also be binding upon the selected firm to maintain the quality of paper as indicated in the quotations.

(i)This office will have the authority to select more than one Firm for award of contract.


(j)The firm should have a well established office, located in Delhi/New Delhi.
